Registration Fees: Early registration for all participants is \$15.00 and includes a T-shirt if registered prior to July 1. Race day registration is \$20.00 for all participants and there will be a limited number of shirts so first come, first served.

I, the undersigned, discharge and release in advance the promoters, sponsors, volunteers, the promoting clubs, the event officials, McCleary Bear Festival Organization, the City of McCleary, the County of Grays Harbor and the respective agents, boards, volunteers, commissions, employees and representatives of the foregoing, without limitation, from any and all liability arising out of or connected in any way with my participation in the above-mentioned event, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

I acknowledge and understand that running/walking a road race is a potentially hazardous activity. I understand that I should not participate unless I am medically able and properly trained. I agree to abide by any decision of race official relative to my ability to safely complete the event. My participation is voluntary and done at my own risk. I voluntarily assume all risks of loss, damage or injury that may be sustained while participating in the above mentioned event including, but not limited to falls, contact with other participants, the effects of weather, including high heat and humidity, traffic, and the conditions of the road, all such risks being known and appreciated by me. I further understand that serious accidents occasionally occur during a road race and that participants in such races occasionally sustain mortal or serious personal injuries and/or property damage as a consequence thereof. Nevertheless I hereby agree to assume those risks and to release and hold harmless all of the persons and entities mentioned above whom, through negligence or carelessness or otherwise, might be liable to me or my heirs, personal representatives or assigns for damages. I agree to accept and abide by the rules and regulations of the event as established and provided to me by the McCleary Bear Festival and to obey the directions of the designated officials.

I understand and agree that medical or other services rendered to me by, or at the instance of, any of the persons or entities mentioned above is not an admission of liability to provide or to continue to provide such services and is not a waiver by any of the persons or entities mentioned above of any right hereunder.
